JUG MOUNTAIN RANCH  
AGREEMENT TO ASSUME ALL RISKS; RELEASE OF LIABILITY/  
AGREEMENT NOT TO SUE & INDEMNIFICATION AGREEMENT**

*Please read this contract carefully before signing. It releases Jug Mountain Ranch from liability and waives certain rights.*

The person who is taking part in the activity shall be referred to hereinafter as "Participant." The term "Undersigned" means only the Participant when the Participant is age 18 or older OR it means both the Participant and the Participant's parent or legal guardian when the Participant is under the age of 18. In consideration for my participation in activities at Jug Mountain Ranch (hereinafter as "JMR"), including but not limited to mountain biking, shuttle rides, hiking, nordic skiing, snowshoeing, bike races, foot races and special events, and my use of JMR, I, the Undersigned, understand, acknowledge, and contractually agree as follows (the Agreement):

**1. Acknowledgement of Dangers and Risks:** The Undersigned understands, acknowledges, and agrees that mountain biking, hiking, swimming, paddle boarding Nordic skiing, snowshoeing or participating in other activities at JMR, and/or using any of the facilities of JMR, including but not limited to use of shuttles, slopes, trails, bodies of water and equipment for activities (hereinafter the "Activity"), can be **HAZARDOUS AND INVOLVE THE RISK OF PHYSICAL INJURY AND/OR DEATH**. The Undersigned understands, acknowledges, and agrees that as a Participant in summer activities at JMR, the Undersigned is a "recreational participant" under Idaho Statute Title 36 Chapter 16 and that participation in the chosen Activity involves certain inherent dangers and risks. **Initial** \_\_\_\_\_

Undersigned agrees that the following dangers or risks are inherent to the Activity, that the following list is not exhaustive, and that there may be other dangers or risks that are inherent to the Activity that are not hereafter listed: variations in terrain; existing, changing, or otherwise dangerous snow or dirt conditions; slick, uneven or otherwise treacherous walking or riding surfaces; rocks, tall and slippery grass, waterbars, ruts, streams, stumps, storms, lightning, hail, snow, fog, changing weather, and other adverse weather conditions; unpredictability of wildlife; attacks by animals; contact with insects and plants; difficulty with route finding; loading, riding in, and unloading shuttles; mechanical or equipment failures or malfunction; unmarked and marked rocks, holes, stumps, trees, and closed areas; collisions with other users of JMR; snow slides; snow immersion; collisions with natural and man-made objects and equipment; falling; equipment damage; pinches; scrapes; twists; jolts; slipping; tripping; loss of balance; varying visibility; unmaintained trails; path and/or trail obstructions; encountering terrain features; Participant's own failure to understand and comply with signage; falling objects; encounters with motor vehicles; lack of shelter; limited access to and/or delay of medical attention; failed or poorly executed attempts at rescue or medical care; Participant's own health condition; strenuous activity; fatigue; dehydration; hypothermia; frostbite; heat exhaustion; sunburn; & mental or emotional damage or distress from exposure to any of the above. I understand that participation in these activities are subject to any and all rules, regulations and policies that are established from time to time by JMR. I ALSO UNDERSTAND THAT HELMETS ARE REQUIRED AT ALL TIMES WHEN MOUNTAIN BIKING on JMR property. **Initial** \_\_\_\_\_

**2. Assumption of Risk:** Undersigned acknowledges and agrees that Participant is choosing to take part in the activity despite the many potential dangers and inherent risks of doing so, and freely chooses to accept the inherent and non-inherent risks of doing so despite the many potential dangers; and further acknowledges and agrees that there are other such dangers that may not be specifically set forth in this document. By signing this Agreement, the Undersigned recognizes that property loss, injury, serious injury, and death are all possible while participating in the Activity. The Undersigned expressly acknowledges and assumes all risks, dangers, and consequences of the Activity, including but not limited to those risks, dangers, and consequences set forth in paragraph 1 above, whether inherent or not, that may result in physical injury, property damage, or death, as provided by the Idaho Statute Title 36 Chapter 16 and by common law. **Initial** \_\_\_\_\_

**3. Participant's Responsibilities and Representations:** The Undersigned represents that the Participant is physically and mentally capable of participating in the Activity. Participant assumes the responsibility of maintaining control and acting safely at all times while engaging in the Activity. Participant is responsible for reading, understanding, and complying with all signage, including the instructions on the use of JMR's facilities and the use of shuttles. Participant agrees and understands that he or she must have the physical dexterity and knowledge to safely load, ride, and unload the shuttles and utilized by JMR. Further, the Undersigned understands that a minor Participant may use the shuttles without an adult present, and represents by signing this document that Participant has the training, experience and skill to load, unload and ride the shuttle vehicles without help or supervision of anyone else. **Initial** \_\_\_\_\_

**4. Release of Liability and Agreement Not to Sue:** Fully understanding the foregoing paragraphs, and in exchange for JMR's agreement to allow the Participant to participate in the Activity, **THE UNDERSIGNED HEREBY AGREES NOT TO SUE** JMR, its affiliated companies and subsidiaries, including but not limited to those that operate JMR, Activity Organizer, Activity Promoter, the United States, or any of their respective successors in interest, affiliated organizations and companies, insurance carriers, agents, employees, representatives, assignees, officers, directors, and shareholders (each hereinafter a "Released Party") for any property damage (including but not limited to equipment damage), injury or loss to Participant, including death, which Participant may suffer, arising in whole or in part out of Participant's participation in the Activity. By signing this Agreement Not to Sue, the Undersigned is releasing any right to make a claim or file a lawsuit against any Released Party. Also, the Undersigned agrees to hold harmless and

release each and every released party from any and all liability and/or claims or causes of action for injury or death to persons or damage to property arising from Participant's participation in the Activity, **INCLUDING, BUT NOT LIMITED TO THOSE CLAIMS BASED ON ANY RELEASED PARTY'S ALLEGED OR ACTUAL NEGLIGENCE** or breach of any contract and/or express or implied warranty. **Initial** \_\_\_\_\_

**5. Agreement to Indemnify:** Undersigned agrees to **INDEMNIFY (REIMBURSE)** each Released Party from and for any and all claims of the Undersigned and/or a third party arising in whole or in part from Participant's participation in the Activity. **IN OTHER WORDS, IF PARTICIPANT AND/OR ANYONE ON PARTICIPANT'S BEHALF FILES ANY LAWSUIT OR BRINGS ANY CLAIM FOR INJURY OR DAMAGE AGAINST RELEASED PARTIES, UNDERSIGNED WILL BE REQUIRED TO PAY BACK TO ALL SUCH RELEASED PARTIES ALL SUMS OF MONEY INCURRED BY, OR PAID BY OR ON BEHALF OF ANY OF THE RELEASED PARTIES ON ACCOUNT OF THE BRINGING OF SUCH SUIT OR CLAIM, INCLUDING ALL ATTORNEYS FEES AND COSTS.** **Initial** \_\_\_\_\_

**6. Medical Authorization, Release, and Indemnification:** The Undersigned: 1) authorizes a licensed physician and/or other medical care provider to carry out any emergency medical care for Participant; 2) authorizes any Released Party and/or their authorized personnel to call for medical care for the Participant or to transport the Participant to a medical facility or hospital if, in the opinion of such personnel, medical attention is needed; 3) agrees that, following Participant's transport to any such medical facility or hospital, the Released Party shall not have any further responsibility for Participant; 4) agrees to pay all costs associated with the medical care and related transportation provided for the Participant; and 5) shall indemnify and hold harmless (as set forth in paragraph 5 above) the Released Parties from any and all liability and/or claims associated with such medical care and/or related transportation. **Initial** \_\_\_\_\_

**7. Application of Agreement to Minor Participants:** In the case of a minor Participant, the Undersigned parent or legal guardian acknowledges that he/she is not only signing this Agreement on his/her behalf, but that he/she is also signing on behalf of the minor and that the minor shall be bound by all of the terms of this Agreement. Additionally, by signing this Agreement as the parent or legal guardian of a minor Participant, the parent or legal guardian understands that he/she is also waiving certain rights on behalf of the minor that the minor otherwise may have. The Undersigned parent or legal guardian agrees that but for the foregoing, the minor Participant would not be permitted to participate in the Activity, and signs this document out of a desire to have the Participant be allowed to participate in the activity. **Initial** \_\_\_\_\_

**8. Representation of Capacity and Authority to Contract:** If signing this Agreement without a parent or legal guardian's signature, Participant, under penalty of fraud, represents that he/she is at least 18 years of age, and that they acknowledge and intend to be bound by all of the provisions of this Agreement. If signing as the parent or guardian of a minor Participant, signing adults represent that they are a **legal** parent or guardian of the minor Participant, and agree and represent that they have the legal right to bind both themselves and the minor Participant to the terms of this Agreement. The Undersigned agrees to indemnify the released parties for all liability and claims, including attorney's fees, arising from any misrepresentations or fraudulent execution of this Agreement. **Initial** \_\_\_\_\_

**9. Acknowledgement that Agreement is a Binding Contract:** The Undersigned understands and acknowledges that this Agreement is a contract and shall be binding to the fullest extent permitted by law. If any part of this Agreement is deemed to be unenforceable, the remaining terms shall be an enforceable contract between the parties. It is the Undersigned's intent that this Agreement shall be binding upon the assignees, subrogors, distributors, heirs, next of kin, executors, and personal representatives of the Undersigned.

**10. Agreement to Application of Idaho Law:** In consideration for allowing Participant to participate in the Activity, the Undersigned agrees that any and all claims for injury and/or death arising from the Participant's participation in the Activity shall be governed by Idaho law, and that the exclusive jurisdiction for any claim shall be in the State District Court of Valley County, Idaho. **Initial** \_\_\_\_\_

**11. Acknowledgement of Rules.** I have received a copy of any rules and regulations associated with the activity, and I have read and understand the same.

**I HAVE CAREFULLY READ THE FOREGOING AGREEMENT AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT I AM RELEASING CERTAIN LEGAL RIGHTS THAT I OR MY CHILD OTHERWISE MAY HAVE.**
