## AGREEMENT NOT TO SUE &INDEMNIFICATION AGREEMENT

Please read this contract carefully before signing. It releases Jug Mountain Ranch from liability and waives certain rights.

The person who is taking part in the activity shall be referred to hereinafter as "Participant." The term "Undersigned" means only the Participant when the Participant is age 18 or older OR it means both the Participant and the Participant's parent or legal guardian when the Participant is under the age of 18. In consideration for my participation in activities at Jug Mountain Ranch (hereinafter as "JMR"), including but not limited to mountain biking, shuttle rides, hiking, nordic skiing, snowshoeing, bike races, foot races and t):

special events, and my use of JMR, I, the Undersigned, understand, acknowledge, and contractually agree as follows (the Agreement):
1. Acknowledgement of Dangers and Risks: The Undersigned understands, acknowledges, and agrees that mountain biking, hiking, swimming, paddle boarding Nordic skiing, snowshoeing or participating in other activities at JMR, and/or using any of the facilities of JMR, including but not limited to use of shuttles, slopes, trails, bodies of water and equipment for activities (hereinafter the "Activity"), can be HAZARDOUS AND INVOLVE THE RISK OF PHYSICAL INJURY AND/OR DEATH. The Undersigned understands, acknowledges, and agrees that as a Participant in summer activities at JMR, the Undersigned is a "recreational participant" under Idaho Statute Title 36 Chapter 16 and that participation in the chosen Activity involves certain inherent dangers and risks. Initial
Undersigned agrees that the following dangers or risks are inherent to the Activity, that the following list is not exhaustive, and that there may be other dangers or risks that are inherent to the Activity that are not hereafter listed: variations in terrain; existing, changing, or otherwise dangerous snow or dirt conditions; slick, uneven or otherwise treacherous walking or riding surfaces; rocks, tall and slippery grass, waterbars, ruts, streams, stumps, storms, lightning, hail, snow, fog, changing weather, and other adverse weather conditions; unpredictability of wildlife; attacks by animals; contact with insects and plants; difficulty with route finding; loading, riding in, and unloading shuttles; mechanical or equipment failures or malfunction; unmarked and marked rocks, holes, stumps, trees, and closed areas; collisions with other users of JMR; snow slides; snow immersion; collisions with natural and manmade objects and equipment; falling; equipment damage; pinches; scrapes; twists; jolts; slipping; tripping; loss of balance; varying visibility; unmaintained trails; path and/or trail obstructions; encountering terrain features; Participant's own failure to understand and comply with signage; falling objects; encounters with motor vehicles; lack of shelter; limited access to and/or delay of medical attention; failed or poorly executed attempts at rescue or medical care; Participant's own health condition; strenuous activity; fatigue; dehydration; hypothermia; frostbite; heat exhaustion; sunburn; & mental or emotional damage or distress from exposure to any of the above. I understand that participation in these activities are subject to any and all rules, regulations and policies that are established from time to time by JMR. I ALSO UNDERSTAND THAT HELMETS ARE REQUIRED AT ALL TIMES WHEN MOUNTAIN BIKING on JMR property. Initial
2. Assumption of Risk: Undersigned acknowledges and agrees that Participant is choosing to take part in the activity despite the many potential dangers and inherent risks of doing so, and freely chooses to accept the inherent and non-inherent risks of doing so despite the many potential dangers; and further acknowledges and agrees that there are other such dangers that may not be specifically set forth in this document. By signing this Agreement, the Undersigned recognizes that property loss, injury, serious injury, and death are all possible while participating in the Activity. The Undersigned expressly acknowledges and assumes all risks, dangers, and consequences of the Activity, including but not limited to those risks, dangers, and consequences set forth in paragraph 1 above, whether inherent or not, that may result in physical injury, property damage, or death, as provided by the Idaho Statute Title 36 Chapter 16 and by common law. 3. Participant's Responsibilities and Representations: The Undersigned represents that the Participant is physically and mentally capable of participating in the Activity. Participant assumes the responsibility of maintaining control and acting safely at all times while engaging in the Activity. Participant is responsible for reading, understanding, and complying with all signage, including the instructions on the use of JMR's facilities and the use of shuttles. Participant agrees and understands that he or she must have the physical dexterity and knowledge to safely load, ride, and unload the shuttles and utilized by JMR. Further, the Undersigned understands that a minor Participant may use the shuttles without an adult present, and represents by signing this document that Participant has the training, experience and skill to load, unload and ride the shuttle vehicles without help or supervision of anyone else.
